BREAKING THE SILENCE

The Memorial Walk took one and a half hours.

Jeremiah was alleged to have run it in 20 minutes!

Family, friends and supporters of the Justice for Jeremiah Campaign travelled to Germany on the 27th March 2009 to participate in a day of events to commemorate how six years ago the body of Jeremiah Duggan was found many kilometers outside of the town of Wiesbaden. This included a memorial walk to retrace the route alleged to have been run by Jeremiah before his death and also the distribution of leaflets to inform people of the town about the meeting to be held later to discuss "Breaking the Silence "about the Death of Jeremiah and the dangers posed by the LaRouche's Schiller Institute.



Hugo Duggan said: "The walk from the flat owned by Rainer Apel, a member of the LaRouche's movement to the spot where the body was found is a very long distance and it took us over one hour.

I do not believe Jeremiah could have run that distance because we have evidence that brings that into question.

The offices of the LaRouche Press agency the Executive Intelligence Review (EIR) is only 10 minutes away.

That is the office where shortly after Jeremiah's death Helga Zepp-LaRouche labeled our son a spy sent over to

harm them and because of this and also because of their suspicious behaviour on the day of our son's death I now

suspect that my son was being held in their offices. For that reason I decided after the walk to go to their offices

and ask to see this Rainer Apel who is alleged to have been the person in whom my son spent his last night.

However not only did no one want speak to me in the EIR offices but they refused to speak to the Media and just

pulled down the blinds. If they have nothing to hide why don't they at least tell us why their manageress was in

possession of Jeremiah's blood stained passport?"

Training schools for Militants held in Hessen:

Erica Duggan stated: "For six years we have tried to find out about the circumstances in which Jeremiah died.

The German police closed the case without even a basic investigation and since then so many families have written to our website www.justiceforjeremiah.com telling me about the dangers of the LaRouche youth movement.

They inform me how the youth are brought in from all over the world to Hessen to be taught to be followers of this group. This is where they train and teach them. This is where my son died. What goes on here? We are here today to break the silence. "

The Duggans speak to the people of Wiesbaden

The Duggans and supporters distributed leaflets in the town of Wiesbaden appealing to the good people of the town to come to the meeting called "Breaking the Silence."

Groups of citizens gathered around the friends of Jeremiah and listened with interest to everything that they said. The people of the town expressed agreement that the attitude of the German authorities and their unwillingness to fully investigate Jeremiah's death and its relation to the LaRouche Schiller Institute is very sad as it shows that the authorities have no concern for the duty of care of so called "cultural or educational or political groups that target the young. Ordinary people in the street were shocked to see how a mother and father and friends had to come all the way from a foreign country to their town to try and find out why someone had died. Many people expressed the opinion that this was not right and took with interest the leaflet and later were seen to be present at the meeting.

Breaking the Silence: Families appeal to the public and the authorities to fully investigate Jeremiah's death and its relation to the LaRouche Schiller Institute.

At the meeting held in the conference rooms of the Plaza Hotel friends of Jeremiah read out a statement reflecting how much his friends remembered him with great love and how much his death came as a great shock to everyone who knew him. The meeting was attended by the Deputy Consul for France who told the French families how seriously the French Government takes the activities of sects that cause students to interrupt their studies.



Statements from families from France and Germany were read out and they all described how their sons and daughters not only were stopped from training for a career but were set to work for hours on end year after year raising money for the organization. The statements by the families showed more about the harming process and proved it was a totalitarian group that had the potential for violence.

French families accuse German authorities of turning a blind eye to the destructive activities of the political cult.

A mother of a youth recruited at an early age described in detail how the group showed all the features of a totalitarian group where every aspect of their lives are controlled by the leaders. She said: "Justice for Jeremiah is also Jeremiah for all of the families." She presented an account of how her son had been subjugation where he appeared to lose not only his independence but also his critical faculties and how shocking it was to hear him professing anti-Semitic conspiracy theories and how this clearly reflected the dangers of people can be manipulated and led astray. This mother called upon the authorities to fully investigate the death of Jeremiah and the Lyndon LaRouche youth movement saying if they have nothing to hide they should welcome full scrutiny.

British University Lecturer speaks about the incitement to hatred against the British and the Jews and the shocking neglect to investigate by the German state in view of these threats posed by the LaRouche youth movement and Schiller Institute.

Dr Matthew Feldman from Northampton University spoke about the role of the LaRouche Schiller Institute in disseminating anti-Semitic conspiracy theories and incitement to racial hatred. He stated: The European headquarters are in Hessen and that places the responsibility on the authorities to thoroughly investigate the dangers for young people. He expressed the view that it remained shocking that the suspicious death of a Jewish man in contemporary German streets remains uninvestigated. "

The meeting ended with ex members of the LaRouche International Group outlining how for 30 years the LaRouche Bueso had been granted a safe haven in Wiesbaden and how they had succeeded in muzzling any attempt to have their activities scrutinized and even had made connections with important groups in the town.

Ex member of the LaRouche network who lives in Wiesbaden outlined the dangers and the threats.

Aglaya Beyes-Corleis an ex member living in Wiesbaden outlined how even though she wrote a book about her experiences and spoke out publicly there had been no action at all by the authorities to curb and monitor the LaRouche Schiller Institute. **Yves Messer**, an ex member from France spoke out about how the LaRouche organization is destructive to Society and a threat to the individual. The meeting ended with an appeal for there to be a breaking of the silence by ex members and families in order to protect the safety of all. This German resident of Wiesbaden spoke out openly about the need for a breaking of the silence as for too long the dangers had been ignored and now that Jeremiah was dead there was no excuse not to thoroughly investigate in order to protect others from harm.

A failure to carry out sufficient investigations: Further evidence submitted last week to the Constitutional Court

Erica Duggan has last week to mark the 6th anniversary of Jeremiah's death been assisted by her lawyers to submit more evidence to the Constitutional Court in Germany to outline in detail the insufficiency of enquiries carried out by the German authorities. This related to the total failure to gather even the barest legal witness statements, to have a medical person examine the injuries to confirm Jeremiah was run over by a car and the way the clothes and shoes

had been lost in spite of the parents request to obtain them.

The German Prosecutor appeared on More 4 News stating that they had investigated the Schiller Institute and it had nothing to do with Jeremiah's death. This is a very surprising comment in view of their previous statements that there was no need to fully investigate as this was suicide. Hugo Duggan stated: " They cannot have it both ways. They cannot say they did not need to fully investigate and then say they did. Also why are they protecting an antisemitic destructive political cult? Is this what the people in Wiesbaden want? We spoke to the people in the street and they were horrified to learn what had happened.."
